Covid Misinformation, Dangerous Treatments Thrive on Apple Podcasts

Apple Podcasts prohibit “harmful and dangerous” content. But the platform is a hub for shows spreading Covid conspiracies—and increasingly, misinformation about monkeypox.

In March 2020, Apple CEO Tim Cook laid out the steps his company was taking to combat the spread of Covid-19. Apple, Cook proclaimed, wanted to “play a role in helping individuals and communities emerge stronger” from the pandemic.¹

Fast forward two-plus years, and one of Apple’s key platforms, Apple Podcasts, hosts a staggering volume of misinformation about the coronavirus—all in direct violation of the company’s own content guidelines, according to a new Tech Transparency Project (TTP) investigation.

Across hundreds of Apple podcast episodes, TTP found that listeners can encounter encouragements to ingest bleach as a Covid treatment, conspiracy theories about the dangers of vaccines, and frequent comparisons of medical professionals to Nazis.

Some episodes have also featured threatening language against doctors treating Covid patients, demanding that they be indicted or executed and disseminating their personal details to facilitate harassment by listeners.

On top of that, many of the serial misinformation spreaders on Apple Podcasts are adapting themselves to new monkeypox outbreak, with hosts calling it a plot planned by “globalists” and a tool for governments to oppress people.

Apple Podcasts guidelines prohibit “content that may lead to harmful or dangerous outcomes.” They also bar “defamatory, discriminatory, or mean-spirited content” that is “likely to humiliate, intimidate, harass, or harm individuals.”²

Apple’s neglectful approach to its podcast platform shows how the company’s lofty talk about corporate responsibility often fails to translate into concrete actions in how it runs its business. In the case of podcasts, Apple is allowing a huge body of misinformation about the coronavirus to reach its listeners, endangering the public at large.

Unlike rival podcast platform Spotify or Google’s YouTube, Apple has shown no apparent inclination to take down the most egregious content. This leaves Apple Podcasts as one of the few mainstream platforms where extremist Covid conspiracist shows can still be accessed.

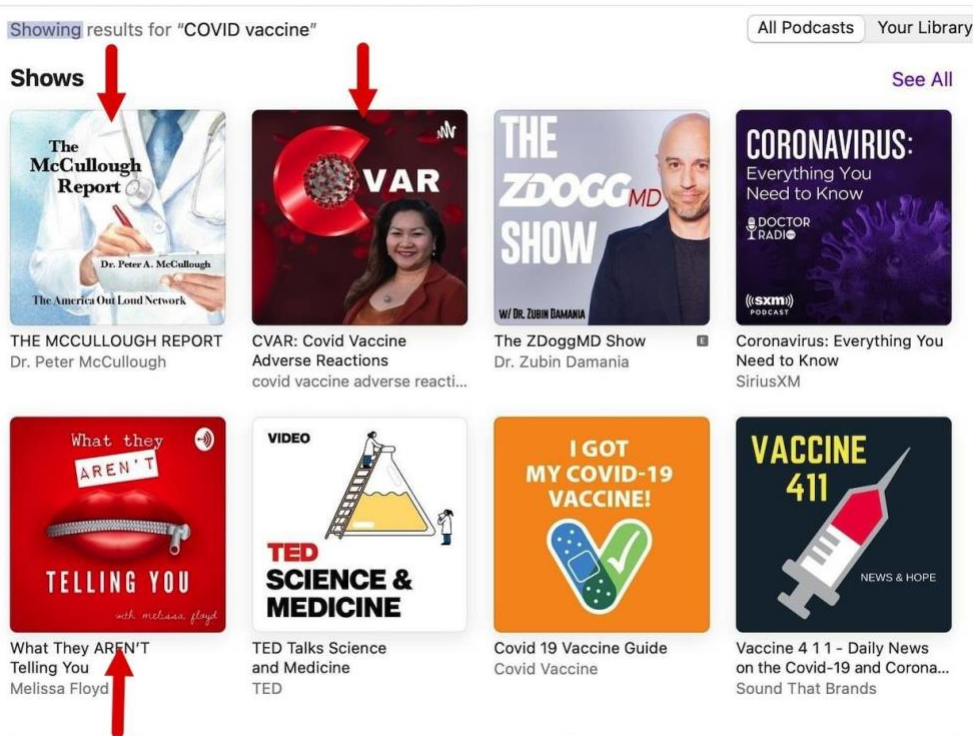
No enforcement of Apple guidelines

Apple’s podcast content guidelines make no specific mention of Covid or medical misinformation, but changes to the guidelines made sometime between May and June 2021 added language prohibiting “content that may lead to harmful or dangerous outcomes,” according to screenshots captured in the Internet Archive.³

Clauses were also added that barred “defamatory, discriminatory, or mean-spirited content ... likely to humiliate, intimidate, harass, or harm individuals or groups” and “specific threats of violence against certain groups or individuals.”

According to the guidelines, Apple reserves the right to label “harmful or objectionable content that is disputed by authoritative sources.” TTP, however, found no labels on the hundreds of podcast episodes examined in this report.

TTP found that Covid-related content in violation of Apple’s guidelines was remarkably easy to find on the platform. Even searches for neutral words like “vaccine” and “COVID vaccine” returned results heavily skewed towards misinformation, placing known conspiracists, disgraced doctors, and other questionable sources above, for example, the podcast of the American Medical Association.



A search for “COVID vaccine” on the Apple Podcasts platform on Aug. 25, 2022, produced three shows that have spread anti-vaccine misinformation.

TTP identified 401 podcast episodes which promoted Covid misinformation and were uploaded between February 2020 and June 2022. We located the episodes through name searches of known Covid misinformation spreaders as well as from recommendations from Apple Podcasts when viewing these results. A full methodology is detailed later in this report.

A total of 90 of the 401 episodes featured at least one of the “Disinformation Dozen,” the twelve individuals identified by the Center for Countering Digital Hate in March 2021 as the source of roughly two-thirds of all anti-vaccine content on Facebook and Twitter.⁴ Two of the dozen, Dr. Joseph Mercola and Robert F. Kennedy, Jr., maintain their own podcasts, which frequently spread medical misinformation, including about Covid. (Facebook and Instagram recently removed Kennedy’s nonprofit for spreading medical misinformation.)⁵

Below, we break down the different kinds of Covid misinformation and conspiracy theories circulating on Apple podcasts.

Crank remedies for Covid-19

Hundreds of episodes analyzed by TTP promoted unproven remedies or prophylactics for Covid. Ranging from turmeric and vitamin C supplements to industrial bleach, these medically misguided “treatments” varied in their potential danger to listeners. Episode descriptions frequently linked to stores selling related medical quackery and often featured advertisements.

Chlorine dioxide

Andreas Kalcker is a notorious advocate for chlorine dioxide as medicine. He is an affiliate of the Genesis II Church of Health and Healing, whose members proselytize “Miracle Mineral Solution,” a mixture containing chlorine dioxide.⁶

Chlorine dioxide is used in a small number of public sanitation facilities to disinfect water. It is safe in very low concentrations, but its gaseous form is toxic when inhaled, and there are no approved medical uses of the compound beyond disinfection of surfaces and equipment.⁷

TTP identified 23 Apple Podcast episodes featuring Kalcker or praising his ideas, totaling more than 17 hours of content in English, German, and Spanish. None of the episodes feature any sort of labeling by Apple Podcasts suggesting that the content may be dangerous or untrue.

Four other episodes were critical of Kalcker, but none of them featured prominently in Apple Podcast search results for “Andreas Kalcker.”

Perhaps the most notable podcast that featured Kalcker is *Evolve with Pete Evans*, hosted by the Australian celebrity chef.⁸ (Evans’ show was removed from Spotify in 2021 for Covid-19 misinformation.)⁹ During a Nov. 2020 interview with Kalcker, Evans “did not tell listeners that the substance his guest was promoting, chlorine dioxide, is a toxic bleach blamed for several deaths, that Kalcker has no medical credentials, or that the research he cited is at best disputed,” according to a report by *Insider*.¹⁰

Ingestion of industrial bleaching agents, particularly chlorine dioxide, has become a popular “treatment” for Covid-19 among some alternative medicine communities and others that reject modern scientific understanding of disease. It’s become especially popular in parts of Latin America, putting a strain on health systems and often pitting elected officials and other authorities who champion the treatment against medical regulators.¹¹

Argentine authorities charged Kalcker with falsely promoting toxic bleach as a medical cure after a five-year-old boy in the country died of organ failure consistent with chlorine dioxide poisoning, according to a September 2021 *Insider* report, which said the boy's parents, based in part on Kalcker's teachings, believed it would protect him from Covid-19.¹²

Kalcker is not the only member of the Genesis II Church getting airtime on Apple Podcasts. The Stew Peters Show hosted Mark Grenon, a self-styled archbishop of the church, in a March 2022 episode promoting the ingestion of chlorine dioxide solution under the name "Miracle Mineral Solution," or MMS. Peters introduces Grenon by listing the diseases and conditions Grenon claims to be able to cure with MMS (including Covid-19, cancer, autism, and AIDS, among others) before lamenting that "Mark's haters say chlorine dioxide is just bleach and they've been fighting to put him and his family members in prison for promoting it."¹³

The interview was conducted remotely because Grenon was in prison in Colombia awaiting extradition to the United States following his indictment on charges of fraud and criminal contempt related to his sale of MMS.¹⁴

TTP also located a recent Apple Podcast episode featuring Jim Humble, founder of the Genesis II Church who also promotes MMS. Humble briefly recanted his claims on the efficacy of MMS but later returned to promoting it, despite repeated warnings about the substance from the Food and Drug Administration (FDA).¹⁵

On a November 2021 episode on the show Extreme Health Radio, the description notes that host Jason Hommel began using tablet forms of the chemical after the smell of the gas became overwhelming. (The substance is toxic in its gaseous form and can cause edema of the lungs and death in high enough concentrations).¹⁶

But that did not deter Hommel from making a wholehearted endorsement:

MMS is a mixture of two substances, citric acid and sodium chlorite, which then creates a solution called chlorine dioxide or stabilized oxygen. According to Mr. Jim Humble, this stabilized oxygen formula in the form of chlorine dioxide doesn't kill any beneficial flora or bacteria in your gut. But it does kill viruses, bacteria, parasites, fungus and gets rid of heavy metals in the body.

Can you start to see the problem the FDA would have with MMS? [...] Autism, malaria, hepatitis, herpes, candida, dandruff, cancer, flu, colds, arthritis, topical burns, warts, skin infections, teeth issues and these are just a few health conditions that MMS might be good for.

Now I have to warn you, MMS is VERY powerful stuff. In fact the FDA calls it "industrial bleach" that will kill you. It's my contention that the FDA is simply scared about the word getting out surrounding MMS. Do you really think the FDA really cares about your health or my health? I don't think so.

But the point is that MMS is incredibly strong and smells like you're swimming in a pool or you just breathed in the chlorine tablets we used to put into our backyard pools.

The smell really becomes overwhelming after a while and I started using the capsule method because I couldn't stand the taste or smell. I did notice a herxheimer reaction or what someone might call a healing response. Perhaps I was killing off too many bugs and poisons at one time.¹⁷

Hydrogen peroxide

The idea of hydrogen peroxide as a Covid-19 treatment has spread on social media, and experts trace the origins of the misinformation to Dr. Joseph Mercola, who reportedly posted a video in April 2020 saying the chemical can "successfully treat most viral respiratory illnesses, including coronavirus."¹⁸ He has made the claim repeatedly across many episodes on Apple Podcasts, at one point stating that he has "never seen anything more effective" for the treatment of viral upper respiratory infections.¹⁹ On one alternative health podcast in November 2020, Mercola stated:²⁰

There's many interventions that you can use that will get you through this [Covid]. So there's very little reason to be fearful of this illness because there's so many simple strategies that [unclear]. My favorite is something called nebulized peroxide. So you use a nebulizer and you simply use very low concentrations of hydrogen peroxide... and just breathe it in.

The devil's in the details, and I've got videos on my site that tells you how to do that, but it's been so impressive seeing people use it who are very sick, or almost felt like they're ready to die, they had a fever, coughing like crazy, just had no energy, felt miserable — and literally within hours they were pretty much normal. That's a consistent response to this.²¹

Mercola is a major figure in alternative medicine with a long history of anti-vaccine activism along with nutritional supplement sales.²² His frequent misinformation regarding Covid-19 has earned him bans from YouTube and Spotify, but his show remains on Apple Podcasts.²³

Hydrogen peroxide is not as toxic as chlorine dioxide, but ingestion is still dangerous and can cause damage to the lungs.²⁴ The use of a nebulizer with hydrogen peroxide has sparked concern from The Asthma and Allergy Foundation of America, which has warned that it could be particularly hazardous for people with asthma.²⁵ There are published medical reports of lung disease associated with prolonged inhalation of hydrogen peroxide.²⁶

Other unproven treatments and drugs

Other pseudoscientific cures for Covid abound on Apple Podcasts. Even in cases where they are not likely to be acutely toxic, the promotion of such unsound treatments is still harmful to society.

For example, colloidal silver, popular as a general health-promoting substance in pseudoscientific circles, can be dangerous when used over longer periods of time and lead to serious medical complications.²⁷ In March 2020, Ralph Fucetola appeared on an Apple podcast called Lost Arts Radio to give the “real” history of pandemics, asserting that vaccines have never really been instrumental in ending infectious diseases and that “the most powerful piece of immune system stimulation that you can use is nanosilver.”²⁸ With his business partner Rima Laibow, Fucetola began selling “nanosilver” products as a cure for Covid-19, drawing the attention of the FDA and leading a federal court to permanently enjoin the pair from distributing the drug in 2021.²⁹

TTP has identified 12 other podcast episodes featuring Laibow, Fucetola, or both since March 2020 on Apple Podcasts spreading misinformation about Covid.

Antiparasitic drugs ivermectin and hydroxychloroquine, which public health authorities have warned against using as treatment of Covid patients, loom large in alternative health and coronavirus conspiracy circles as well.³⁰

The promotion of ivermectin and hydroxychloroquine as functional cures for Covid-19, in the face of strong scientific evidence to the contrary, fuels distrust and anger at the modern medical establishment as patients and their relatives criticize doctors' refusal to use the drugs.

For example, Dr. Simone Gold, a January 6 insurrectionist and founder of the misinformation group America's Frontline Doctors, tells listeners:³¹

*The National Institute[s] of Health right now has as its policy, Recommendation for Patients with Covid-19, stating that unless you're in the hospital requiring oxygen there's no actual treatment available for you. That is a complete falsehood. Completely false. In most of the world, non-first world countries, there's plenty of treatment easily available—hydroxychloroquine, ivermectin. [...] This is a crime against humanity. There's a physician in the Netherlands who's bringing a lawsuit in The Hague, calling it a crime against humanity. There was a lot of information you haven't heard. [...] I start with that because when you understand, you must understand the magnitude of the lie to understand what they're trying to tell you about these experimental vaccines, so we need to just kind of go through that for a little bit.*³²

The two antiparasitics are often recommended as part of a suite of other unproven treatments. For example, in an October 2021 podcast interview, Dr. Pierre Kory, a prominent member of the fringe doctors' group Front Line COVID-19 Critical Care Alliance, recommended a litany of prophylactics for Covid including ivermectin along with cumin, honey, curcumin, androgen suppressants, and vitamin D.³³

In that episode, Kory quickly followed up with a disclaimer that "I'm not saying that everyone should take all this. Really, this should be done with the guidance of a physician." Tellingly, though, he continued, "But I also have to be honest, you know, we have to say those disclaimers, but at the same time as a physician, there are people who are not getting the care that they need, they're not getting the expertise," implying that people may need to take matters into their own hands.³⁴

Robert Scott Bell, a homeopath who is banned from Spotify and YouTube but still hosts a podcast on Apple, illustrates this phenomenon in an episode about “pandemic truth”:³⁵

Well, I think everybody should have a nebulizer at home just in case. [...] We have nebulized the silver hydrosol, the argentyn-23, now the copper hydrosol, to oxygenate and heal tissue or address genuine infections, whether it be bacterial, fungal, or viral, we can do that safely.³⁶ [...] Especially if you have kids, we’ve used the nebulizer with kids, and my kids are not chronically ill like my wife and I were growing up. We were heavily vaccinated, my wife even more so as a civilian military brat. The millennials—more vaccinated than any other generation in history—have chronic diseases almost from the get-go, and I did as a child. I was the canary in the coal mine. So I raised my kids differently and I did not vaccinate them, and they’ve never even once had an antibiotic and now at 22 and at 16 they have none of the chronic diseases that my wife and I [had] growing up.³⁷

Bell views mainstream medicine as “overtly evil” and thus believes “the most dangerous thing that you can have in America is really good medical insurance.”³⁸

This skepticism of modern medicine translates for some into a wholesale rejection of hospitals for treatment of Covid. In the words of Nicole Sirotek, a nurse speaking on The Stew Peters Show in January 2022, “How you can avoid literally dying in the hospital is stay out of the hospital to begin with. You just need to avoid the hospital at all costs and the way to do that is to make sure that you’re ready with early intervention,” namely, a litany of unproven treatments that competent medical authorities have warned against using.³⁹

Vaccine misinformation and conspiracy theories

Apple Podcasts also hosts a vast quantity of misinformation surrounding Covid-19 vaccines, with podcast hosts and guests across numerous episodes repeating false claims about the vaccines, their contents, and their effects.⁴⁰

Among the more bombastic claims: billions will die from the Covid-19 vaccines; people died due to the vaccine in clinical trials; and more will die from the vaccine than from Covid-19 itself.⁴¹ These ideas are frequently paired with general vaccine skepticism.⁴²

The vaccine claims are often part of a paranoid view of the world completely detached from reality. Speaking of doctors, public health officials, regulators, and others involved in implementing what Covid conspiracists consider to be the greatest crime in history, serial misinformation spreader Dr. Sherri Tenpenny informed listeners:

The people that are doing what they're doing, they are Luciferians, which means they love Lucifer, and they're Satanists, meaning they worship Satan and everything that he represents. We know that they are absolutely anti-God [...] And I was listening to a video yesterday of a guy who was saying, y'know, now that we have injected human beings with nanobot—nanotechnology, we've created—we're in the process of creating the Hive Mind, where everybody will be put together through the quantum entanglements of what they have injected in us and us binding up with the quantum computers out there. [...] The whole idea is to become transhumans, to be electronically controlled, externally by 5G and other types of technologies through this quantum entanglement, and when we are entangled, ourselves, our souls [...] our little spark of life that came only from God is completely eliminated.⁴³

Vaccine misinformation is not confined to obscure podcasts. Several anti-vaccine activists and disgraced doctors pushing Covid-19 misinformation have been featured on The Charlie Kirk Show, which currently ranks 24 among all news podcasts on Apple Podcasts (as of Sept. 14, 2022). Kirk, a prominent Republican activist, does not substantively contest any of the claims made by his guests in these episodes.⁴⁴

Woven through the Apple Podcast episodes analyzed by TTP were baseless conspiracy theories and extremist fantasies regarding Covid-19. This content has been available on Apple Podcasts throughout the pandemic, encouraging listeners to not only take bogus treatments and supplements if they get sick, but to view medical professionals as Nazis, reject public health measures as totalitarianism, and ultimately embrace a belief of nihilistic paranoia about the world around them.

In the early months of 2020, guests on several shows downplayed the seriousness of the emerging pandemic. On March 11, Sayer Ji, a prominent alternative medicine advocate and spiritualist, insisted that fear of the coronavirus was far more potent than the disease itself, “not that different from in the Middle Ages when demons used to plague people.”⁴⁵

In a similar vein, on an anti-vaccine podcast called the Vaccine Conversation with Melissa and Dr. Bob, host Melissa Floyd noted that Americans shouldn’t be too concerned with the virus and questioned whether “the media and government [are] spreading unwarranted fear in order to justify removing personal liberties,” suggesting that’s what happened with the measles. (The hosts also opposed the measles vaccine.)⁴⁶

In a March 26, 2020, interview with fringe documentary maker Maryam Henein on another podcast, Henein insisted that the concern about the coronavirus was just “fear porn” and that PCR tests and fatality counts were completely inaccurate. She also speculated that images of the pandemic coming out of China were actually just staged in Taiwan.⁴⁷ The end goal, she said, was authoritarian classification of humans and to “insert us with vaccines.”⁴⁸

Some podcast episodes are even specifically devoted to undermining public health efforts. For example, a more recent March 2022 podcast episode examined by TTP focuses on helping members of the military to avoid mandatory Covid vaccinations by applying for bogus religious exemptions.⁴⁹

Kevin Jenkins, one of the “Disinformation Dozen,” regularly spreads doubt about public campaigns to encourage Covid vaccination among Black Americans, who have remained disproportionately unvaccinated in many states.⁵⁰ In his words: “The Black bourgeoisie, the Black political class, the Black health professionals, all of them that are promoting [the vaccines] are war criminals and modern-day slavecatchers.”⁵¹

So you got celebrities, black celebrities being paid off by Big Pharma and Big Tech, right? And you got the government that has failed all of us, right? You have major corporations that are going to be used as a third party to apply more pressure on us and now they're moving into the vaccine passport, which is slavery at another name, maximum slavery at another level. So as a Black American and who was rooted in its history, I understand what slavery is. And this is a continuation of the Negro Project by Margaret Sanger. This is 3.0 eugenics. This is the final, final solution.⁵²

Some episodes veer into antisemitism, which appears to be prohibited under Apple Podcasts guidelines.⁵³ On the Sean Morgan Report in May 2020, conspiracy theorist Robert David Steele—who has since died of Covid-19—said either “Zionists or some other deep state agent” likely planted the virus as a form of “biological drop.”⁵⁴ He pointed to a “hapless Jewish professor at Harvard, [who] may have been given up by the [Israeli intelligence agency] Mossad in order to create a distraction, kind of like the magician’s assistant saying, ‘Oh, look over here, there’s a Chinese virology lab,’ but in fact, it was a deliberate drop” in Christian cities.⁵⁵

Steele appeared on another podcast later that month, where he continued to spout unhinged theories about global conspiracies and pedophiles in government working to push the pandemic narrative. The episode description links to a free e-book with a foreword by Steele, *Pedophilia & Empire: Satan, Sodomy, & The Deep State*, which contains extensive sections repeating antisemitic blood libel claims.⁵⁶

Other Covid truther and extremist podcasts display a fondness for allusions to Nazi Germany, arguing that temporary mask mandates and social distancing guidelines are somehow comparable to the Holocaust. They frequently say modern doctors and medical authorities are violating the Nuremberg Code, a set of medical ethics principles formulated in response to Nazi medical experimentation.⁵⁷ In the words of Stew Peters:

*Obviously the Holocaust and the betrayal of Christ were some of the worst crimes ever perpetuated in human history, but I genuinely believe that **what we have lived through in the past two years is one of the greatest crimes in human history as well.** [...] And then there’s **what our hospitals are doing, just like the SS guards who went on trial almost 80 years ago.** It’s clear there’s a lot of doctors out there who are actually sadists at heart. They love the rush they get wielding the power of life and death over*

*people. They get off on the idea of kicking people out of their hospitals for not having the vaccine, and yes, they absolutely enjoy mistreating or ignoring the people in their care to punish them for not doing what they're told to do. I believe that in a just world, when this whole Covid nonsense is said and done, there will be trials for everything that has happened so far. [...] For the people who masterminded lockdowns and mask mandates and maintained them for months for political reasons, and yes, for **all the little Joseph Mengeles in our hospitals who enjoyed inflicting pain and death and people who indulge in their own power trips and collect blood money along the way. Some of these people, like Tony Fauci, they very well deserve the death penalty.***⁵⁸

Listeners immersed in the information flooding from these shows may become increasingly detached from reality. These conspiracy theories can and do kill people who succumb to them, leaving behind estranged, grieving friends and family members.⁵⁹

Rivals beat Apple at fighting misinformation

Apple's podcast rival Spotify came under fire in early 2022 for its contract with Joe Rogan, who has hosted guests who spread demonstrably false and misleading information about Covid-19.⁶⁰ This was not the first time that podcast platforms had come under scrutiny for hosting misinformation; in November 2021, *The New York Times* reported on the problem, naming a handful of concerning podcasts.⁶¹

News reports suggest Spotify has begun to counter some (but not all) of the most egregiously harmful Covid-19 misinformation on its platform in recent months, but TTP's investigation shows that Apple has consistently declined to act.⁶²

The case of David Icke on the London Real show in April 2020 exemplifies Apple's inaction. The show's YouTube channel, which boasts over two million subscribers, aired an episode featuring Icke, a well-known British conspiracy theorist, and also published it as a podcast episode. (Host Brian Rose disclaimed that he did not necessarily agree with everything Icke says, but shortly after praised him for his courage to speak the truth.)⁶³

Over the course of two-and-a-half hours, Icke asserted that there is not really a coronavirus pandemic because viruses do not exist. So-called Covid, he argued, is actually the result of poisoning by 5G waves—a plot by a global cult to engineer the new world order. Rose did not push back against Icke's claims and hosted him again for a three-hour episode the following month.⁶⁴

After inquiries from CNBC, Spotify removed the episode, but Apple did not. (YouTube and Facebook had already removed Icke's accounts.)⁶⁵ TTP has identified an additional 10 episodes featuring Icke discussing Covid on Apple Podcasts.⁶⁶

This proved to be a pattern in Apple’s behavior: When informed of dangerous medical misinformation on its podcasts by the media, the company has declined to comment or take any action.

A QAnon conspiracy theory podcast, SoulWarrior Uncensored, was highlighted in an Associated Press report in January 2021.⁶⁷ The AP article noted that Spotify took it down after inquiries, but Apple and Google left it up.⁶⁸ Then, in November, *The New York Times* detailed several Covid-19 misinformation-heavy shows on Apple Podcasts whose hosts had died of the disease. Apple declined to comment and none of the shows appear to have been removed or labeled.⁶⁹

TTP identified 12 shows that sit on the extreme end of the Covid-19 misinformation spectrum and are banned by YouTube and/or Spotify but still remain on Apple Podcasts and Google Podcasts.⁷⁰ These shows are particularly frequent sources of vaccine misinformation and promotion of bogus Covid treatments. Some contain regular calls for violence against public officials and targeted harassment against hospitals and medical workers.

The numbers show that while Spotify and YouTube have moved to limit the reach of some Covid-19 misinformation, Apple Podcasts stands as an increasingly rare mainstream platform that welcomes it.

Next up: monkeypox

In May 2022, the World Health Organization confirmed an outbreak of monkeypox in multiple countries outside of the virus's normal endemic range.⁷⁷ As the outbreak made international headlines, Apple Podcasts became a platform for spreading doubt and mistrust of public health authorities' statements about the disease, mirroring the Covid misinformation documented in this report.

A search for "monkeypox" on June 16, 2022, returned several episodes featuring misinformation content regarding the disease.

One episode was from The Stew Peters Show on May 31. Peters opened his show with a monologue on monkeypox, including homophobic remarks that would appear to be prohibited by Apple Podcast guidelines:

So now the genocidal psychopaths are beginning to panic and the CDC is now raising travel alerts for monkeypox. There have been just about 200 cases in more than 20 countries, most of them concentrated, of course, among homosexuals, who to no surprise have spread the virus through their promiscuous and disgusting sexual depravity. At least, that's the official story. But incredibly enough, globalists were plotting the course of a monkeypox outcome at this exact time a year ago.⁷⁸

Peters was echoing a popular conspiracy theory that has arisen in response to the monkeypox virus; the theory posits that monkeypox (like Covid) is a planned pandemic.⁷⁹ The other Stew Peters episode found in the search featured Jane Ruby, who denied that there were any truly confirmed monkeypox cases.⁸⁰ (The episode also featured a guest who called for Anthony Fauci to be hung for treason, and claimed that LGBTQ people are indoctrinating children like Nazis.⁸¹)

In an episode of The Highwire with Del Bigtree, Bigtree muses about the possibility of monkeypox as a planned pandemic, citing previous out-of-context statements by Bill Gates. Bigtree maintains that Covid was a failed attempt to strip people of their privacy and freedom; monkeypox is "nothing to be afraid of" but may well be a tool by governments to oppress their people, he said.⁸²

A vaccine effective against monkeypox exists, and the virus is unlikely to spread as rapidly as Covid.⁸³ But it's clear that in the absence of Apple enforcement, the company's podcast platform will continue to be a haven for misinformation about disease outbreaks.

Targeting doctors

TTP's investigation shows how Apple is also turning a blind eye to harassment of medical professionals targeted by far-right and extremist podcasts during the pandemic.

TTP tried to reach the doctors targeted by these podcasts via their contact information online, or if that couldn't be located, via their affiliated hospitals. TTP also sought separate comment from the hospitals. None responded to TTP's request for comment, which may not be surprising, given the harassment campaigns described below. TTP is not naming the doctors to protect their safety.

Three of the four harassment campaigns identified by TTP originated with The Stew Peters Show, available on Apple Podcasts. Like many podcasts, the show appears to remove older episodes as newer ones are added. Thus, any harassment campaigns that may have been initiated by Stew Peters before November 2021 were not discoverable in our searches.

Peters' extremist views make him a fringe personality even on the far right. Peters has repeatedly called for the execution of public figures such as Dr. Anthony Fauci, the government's top infectious disease expert, over alleged crimes related to Covid-19, including on at least one episode of his podcast.⁸⁴

Spotify took down Peters' podcast in late 2021, citing company policy against dangerous or deceptive content about Covid-19. As of September 2022, the show remains on Apple Podcasts. In response to his ban from Spotify and iHeart, Peters called the two companies "the propaganda arm of the communist, globalist genocidal machine, hellbent on the destruction of freedom, Christianity, and truth."⁸⁵

On March 21, 2022, Peters alleged that Apple Podcasts did remove his show from the platform without notice, detailing the situation in a post on Gab, the far-right alternative social media site.⁸⁶ (He also claimed that "Millions and millions and millions of people listened to and downloaded the daily show" on Apple's podcast platform.) The ban, if genuine, appears to have been short-lived; TTP was able to access The Stew Peters Show throughout April, and it remains on the platform today, updated several times a week.

Mercy Hospital and the Scott Quiner case

In January 2022, a Minnesota hospital drew the ire of Peters after moving to end life support on a terminally ill Covid patient. The resulting harassment campaign compromised the ability for the hospital to function properly, Peters boasted. Peters declared that medical professionals needed to “suffer” before being indicted and executed:

*So everybody that's out there that's saying "Stew, please platform this case," we're gonna continue to do that, because **we want these hospitals to fear that they're next and we want them to know that the entire world is watching.** And the bigger the audience gets here at The Stew Peters Show the better because we just weaponize it for good and then these people are flooded. Mercy Hospital said they had 300,000 phone calls, they had to completely shut their switchboard down, **that's excellent because these people need to suffer. And when we indict them and we try them and we fry them, that's gonna be great.**⁸⁷*

The campaign stemmed from the case of Scott Quiner, an unvaccinated man hospitalized for severe Covid in late 2021. He was put on a ventilator and then transferred to the ICU of Mercy Hospital in Coon Rapids, Minnesota, on Nov. 6.⁸⁸ He remained on the ventilator for over nine weeks.

Mercy Hospital staff informed his wife Anne that they intended to disconnect Scott from the ventilator that week. In a phone call with Anne played on the podcast, a Mercy Hospital doctor stated that “at this point his lungs are so destroyed, unfortunately, from the Covid pneumonia, [that] all of our experts do not believe that there is any chance that you will have any lung recovery.”⁸⁹

In January 2022, Mercy was at 100% ICU bed occupancy, a rate that has remained constant since September 2020.⁹⁰ A local media report on January 12 described the hospital as “overwhelmed” by surging Omicron-variant cases, affecting both staff and patients and, according to the hospital’s emergency medical care director, “crushing ... our ability to take care of patients.”⁹¹

Anne Quiner appeared on The Stew Peters Show to raise awareness of her husband’s case. Peters’ episode, released on January 12, appears to be the first to publicize the case, which was covered in mainstream media in the following days. The Minneapolis *Star Tribune* specifically credits Peters’ show for bringing attention to the Quiners.⁹²

On the show, Anne played recordings of her phone call with Mercy Hospital doctors informing her of the decision to remove Scott from life support, in which she contested the idea that a vaccine would have protected her husband.⁹³ Peters pressed Anne for specific names of the doctors involved.

Peters: Since when did Mercy Hospital become the Gestapo? How can they imprison him? How can they do this? They can't. The answer is that they can't, and we're gonna get an attorney paired up with you right away. Also, in the meantime — Mercy Hospital — who is the doctor whose care is — Scott is under. Who's the doctor that's making this decision to just arbitrarily kill your husband against your wishes? [...]

*These people are cold-hearted. Cold-blooded killers is what they are. And they're doing it for a paycheck because Mercy Hospital, just like all these other care providers, are for-profit businesses. We're not gonna stand for it, you're a fellow Minnesotan, and this audience, by the way, **The Stew Peters Show boasts the best audience — we're a family — of any show out there. And I guarantee you these people at Mercy are gonna hear from them. We're gonna put all their numbers at stewpeters.com as well as on Rumble [an alternative video platform]. It's here right now in the Rumble description, please call them. We're gonna put social pressure on these people and get you teamed up.***⁹⁴

The episode's description on Apple Podcasts provided contact information for the hospital as well as specific employees:

*A Minnesota hospital has told Anne Quiner, wife of Scott Quiner, that they plan to pull the plug on her husband's ventilator life support without her consent due to Scott needed [sic] "excess care" due to his unvaccinated status. Anne Quiner joins us to discuss. Light up the Hospital! Mercy Hospital 4050 Coon Rapids Blvd Coon Rapids MN 55433 Main line [Phone number] Scott Quiner is in the Heart and Vascular Center Their number is [Phone number] [First name] is the Care Coordinator [Phone number].*⁹⁵

Anne sued to stop the hospital, and a day later, a judge issued a temporary restraining order requiring the ventilator be maintained for 30 days. The decision drew criticism from some Minnesota doctors.⁹⁶ Scott Quiner was then transferred to a hospital in Texas, where he remained on a ventilator. He died on January 22.⁹⁷

Listeners of the show took particular issue with the doctors L.S. and R.E., who, on the original phone call with Anne, informed her of the decision to remove her husband from life support. On his January 17 episode (entitled “Scott Quiner Update: Criminal Investigation Into Doctors, How They’re KILLING, Payoffs for MURDER!”), Peters said:

*The hospital was actually forced to remove Dr. [R.E.] and Dr. [L.S.] from their website due to an explosion of traffic and emails sent through the Allina Healthcare website. And the switchboard phone answering method had to be altered completely. **The hospital even got the local sheriff involved, saying that they were being harassed. Local news media desks were asking people calling them to stop calling the hospital because they — quote, “because they couldn’t get any work done with all of the calls.” — Couldn’t get any work done? Good! That may have inadvertently saved many other lives. Because we know what their "work" is.***⁹⁸

TTP could not independently verify the extent of harassment. Mercy Hospital did not return TTP requests for comment on the controversy.

Regardless, the episodes detailing the Scott Quiner case on The Stew Peters Show constitute “content is likely to humiliate, intimidate, harass, or harm individuals or groups,” which is forbidden by Apple Podcast guidelines.⁹⁹

Dr. K. W.

On January 24, 2022, The Stew Peters Show hosted Shamgar Connors, a man suffering from acute kidney failure who refused vaccination for Covid-19. Connors was removed from the active kidney transplant recipient list by the University of Virginia University Hospital due to this refusal.¹⁰⁰ Similar policies regarding Covid vaccinations and transplant eligibility are used at some health systems in the United States and Canada.¹⁰¹

Connors was thus placed on the inactive kidney transplant list. Patients on the inactive list still accrue wait-time that advances them further on the active list but cannot undergo transplant surgery until they are placed on the active list.¹⁰²

Stew Peters introduced Connors’ case with a characteristic dose of anti-vaccine sentiment:

*Shamgar is obviously a leading candidate for a kidney transplant, which could allow him to live a longer and more normal life again. But Shamgar was just informed that he has been taken off of the active transplant list and put on the inactive list because, yes, you guessed it, **he refuses to be jabbed with the dangerous and deadly Covid-19 clot shots being falsely referred to as an approved, safe and effective vaccine — none of that is true.***¹⁰³

Peters then continued to press for details and encourages listeners to contact the hospital:

- *PETERS: What specifically are you going to do to combat this? What is the name of these people that are denying you this transplant? I wanna know, who are these people?*
- *CONNORS: The University, uh, UVA Hospital, they are the ones doing this, and [K.W.] is the name of the doctor I spoke to on the phone. [...]*
- *PETERS: Alright, [K.W.] is the doctor. Now is she making this decision? Is [K.W.] at the University of Virginia Medical Center, is —*
- *CONNORS: Sounds like she was just following policy because the way that she spoke to me on the phone, if anyone wants to listen they can hear the whole recording, and sounds like she was just saying that's what the policy was —*
- *PETERS: Yeah, she's just following orders! [...]*
- *CONNORS: And she did that because [I] won't get an experimental drug that's dangerous.*
- *PETERS: Exactly. That's what this is. **This is the death panel by the coronavirus death cult that wants to shame you and then put you on display: Look, here's another unvaccinated patient dead! No, here's somebody who was denied life-saving medical attention, whose life was then put in risk by you, and that's what the fact is. Shamgar Connors, I'm out of time, I gotta go. We're gonna flood these phone lines — by the way, do you have some sort of a way that people can come and find you and follow your story?***¹⁰⁴

When asked by the doctor if he would consider receiving a Covid vaccine, Connors replied, “I’d rather die of kidney failure.”¹⁰⁵ Connors later received multiple donation offers from private citizens, all of which he refused, citing his belief that no one should ever be required to receive the Covid vaccination as a condition of transplant.¹⁰⁶

Dr. J.F.

One Missouri pediatrician, Dr. J.F., presented at a Covid taskforce at her hospital, and in so doing drew the ire of extremists in January 2022. The specific hearing mentioned in these podcasts and social media posts is unclear; the relevant materials are not on the hospital's website.

According to the Stew Peters Show, J.F. discussed her care for children with severe Covid, done in accordance with CDC guidelines—an unforgiveable crime in the eyes of extreme conspiracy theorists, tantamount to murdering children. The Stew Peters Show drew attention to J.F. through guest Jane Ruby, who has a track record of spreading dangerous misinformation about Covid vaccines, which she maintains are filled with chemicals.¹⁰⁷ Ruby explained:

I wanna to call particular attention on your show today to a pediatrician in Missouri... her name is Dr. [J.F.], she recently presented as part of a Covid task force to a local hospital where she is acting as an advisor, and she advised everyone that she is apparently putting children on remdesivir. I don't even know if there's a pediatric dosing because it is under emergency use authorization, which means it's experimental and hasn't been— hasn't completed its studies, so what is the dose adjustment? We don't know for children.¹⁰⁸ But she's apparently putting them on remdesivir, which we know for a fact damages, permanently in some cases, renal function, kidney function, and she told them that part of — the other thing she's doing, is that she is moving them on to ventilators.¹⁰⁹ [...] Dr. [J.F.] admitted that even though she continues to use this protocol, children are dying on it, and her response was, "I'm just following the CDC's recommendations for pediatrics on their website."¹¹⁰

Ruby also named two specific hospitals that were treating critically ill patients. She first mentioned the case of a ventilated patient at Torrance Memorial Medical Center in Torrance, California, which she alleges held the patient against the family's will.¹¹¹ (Removing a patient from a ventilator prematurely could be extremely dangerous.)

She also names Mt. Sinai West Hospital in New York City, providing its address and a phone number and urging listeners to “to call and encourage the hospital to give him the proper treatment with Ivermectin and HCQ and to stop using protocols that just result in death.”¹¹²

Later in the episode, Peters returns to J.F.:

- *PETERS: I'm disgusted by this pediatric — what's her name here? Let's put her up on the screen again here. What's her name again? Who is this?*
- *RUBY: Dr. [J.F.] She is at — this hospital is—*
- *PETERS: I don't like her. I really don't like her.
[Ruby gives the name and location of the hospital]*
- *PETERS: **But this lady here, I can't stand her. She's disgusting, this woman. Look at her. She's just a tyrant. She's a murderous tyrant. And she's doing it knowingly. It's disgusting. [...] People should let her know how they feel, that's my opinion.***¹¹³

The show then cut to an advertisement for a “Z-Stack Protocol” multivitamin sold by Dr. Vladimir Zelenko, promising to protect against “the jab that becomes self-spreading bioweapons, threatening the purebloods.”

Sean Turnbull and Dr. E.C.

“SGT Report’s The Propaganda Antidote,” a far-right conspiracy theory show hosted by a Minnesota man named Sean Turnbull, has targeted Dr. E.C., a pediatrician in the state, for months. Turnbull has mentioned her in at least 13 episodes since first drawing attention to her on January 4, 2022.¹¹⁴

E.C. has appeared in local T.V. ads encouraging people to vaccinate their children, drawing the ire of anti-vaccine extremists. In that sense, E.C. could be considered a minor public figure, but the contempt Turnbull displays for her is nonetheless disturbing.

SGT Report has been barred from numerous social media platforms, including Twitter, Vimeo, and YouTube, but it remains on Apple and Google Podcasts.¹¹⁵

Turnbull solicited input on E.C. from Dr. Vladimir “Zev” Zelenko, who proceeded to compare her to a Nazi:

- *TURNBULL* When I asked Dr. Zev Zelenko about what should happen to doctors like [E.C.], here's what he said:
- *ZELENKO*: I hope you'd [be] brought justice at the national tribunal, because your advice is akin to what the medical establishment did in Nazi Germany that led to the massacre of millions of people. And so, there's no indication — zero indication — to give healthy children this vaccine because children, according to the CDC, have a 99.998% recovery rate from Covid with no treatment. And Dr. Michael Yeadon, who you mentioned earlier, says these vaccines are 100 times more lethal than the actual virus.
- *TURNBULL*: Before we move on, just a quick final word to [E.C.]: **Repent. You are on the wrong side of history and there is blood on your hands.**¹¹⁶

Turnbull accuses E.C. of collusion with “Big pharma, big media, and big government” in hiding the effects of Covid-19 vaccines on pregnancies. In his telling, E.C. is a part of the wider Covid-19 conspiracy, which is “absolutely evil, from-the-pits-of-Hell diabolical.”¹¹⁷

SGT Report does not appear to reveal E.C.’s details beyond her name and profession in the podcast episodes, but on a livestream recorded on its website, Turnbull showed a picture of her along with information about her place of work, including its address and phone numbers. In the same video, Turnbull shows a one-star Google review he left of E.C.¹¹⁸

Methodology

The content in this report is based on a collection of 401 episodes gathered in March 2022, and supplemented in the following months by subsequent research.

TTP gathered an initial sample of 374 podcast episodes based on name searches of known purveyors of Covid misinformation. TTP only included episodes from February 2020 or later in English, in which Covid was a major topic of discussion. A total of 38 episodes were removed from the list because they did not meet such criteria. Two additional episodes in which the hosts substantively challenged untrue claims made by guests were removed as well.

Another 67 episodes featuring Covid misinformation and other relevant content were added as they were encountered in the course of TTP's investigation, sometimes via Apple recommendations for similar podcasts.

For the vast majority of Apple podcast episodes, reading the descriptions confirmed that the content was misinformative. In some cases, TTP researchers listened to or read machine-generated transcripts of episodes, to determine if the content was misinformative or to examine the content more closely. In total, TTP researchers examined over 70 hours of content via listening or transcript.

The final list of 401 episodes is not necessarily a comprehensive sample of Covid misinformation on Apple Podcasts. TTP largely focused on episodes that included evidence of misinformation in their title or description; podcasts that spread Covid misinformation but did not describe it in their title or description may have been left out. In addition, some podcasts appear to take down older episodes after a period of weeks or months, likely as a way to keep them exclusive to subscribers on another platform, meaning some misinformation-spreading episodes that reached an audience on Apple Podcasts are no longer available to count.

For the purposes of this report, "Covid misinformation" refers to information that is clearly false and misleading related to the novel coronavirus disease. Examples include assertions that the virus is not real, that masking is harmful to wearers, and that approved vaccines are exceptionally hazardous to recipients.

We did not include opinions about the social implications of some policy decisions, such as the argument that lockdowns were on balance bad for the public, nor did we include false statements about the disease that were the result of contemporary misunderstanding of the virus (e.g., a statement in February 2020 questioning whether Covid was airborne).
